a) Special Account Ledger (Auction Fund) - May 2023

b) Monthly Overtime (Paid and Banked) - May 2023

The Chief reported that there was an increase in overtime for May and this attributed to the missing child incident. There was also an attempt homicide and a significant warrant that took place over multiple days. When compared with the previous year, the overtime is on pace for spending.

c) Monthly Staff Shortage Overtime Costs (3 Year Comparison) - May 2023

The Chief reviewed the report.

d) Monthly Staff Shortage Costs (Patrol & CERB) -May 2023

The Chief reiterated that this report reflects the overtime costs associated to the missing child incident. Sonny asked how the overtime was calculated and the Chief clarified this reflects the overtime cost only.
