John asked about the protection of personal information in the registry and who would be able to access the information. Sgt. Stevenson advised that he contacted multiple police other agencies to see how their system works. There is a liability form that is completed, giving approval for first responders to use the information. Our form is very robust and meets all the criteria of MFIPPA. Only officers should be able to view the information but we may share with other agencies if there is a need to know, such as Fire Services. The information stays within our Records Management System and we are the only ones to disseminate the information.
