8. Communications & Reports - Information Only

a) Special Account Ledger (Auction Fund) - March 2024

The Chief reviewed the report and noted there were no changes.

b) Monthly Overtime (Paid and Banked) – March 2024

The Chief reported that overtime has gone up as a result of the Project Teal takedown.

c) Monthly Staff Shortage Overtime Costs (5 Year Comparison) - March 2024

The Chief noted there has been an increase to sick time, resulting in overtime.

d) Monthly Staff Shortage Costs - March 2024

The Chief reviewed the report.

e) Budget Report - Ending March 31, 2024

The Chief reported that we have spent 17% in the first quarter and are well within our 25%.

f) Year End Statistical Report - 2023

The Chief reviewed the year end report for 2023 and noted that assault have maintained, sex assaults are down significantly, homicides have increased significantly, and attempt homicides are also up. All of these types of occurrences are

extremely expensive. The Chief also noted that with regards to crimes of property, break and enter totals were down but businesses were up. Residential property crime was down, as well as attempt break and enters. IPV incidents were relatively the same.

The Chief reminded the board of the IPV pilot project and noted that 197 follow up calls have been conducted and out of them, 9 have generated new incidents and out of those, we have laid two charges. This has been since March 5, 2024.

Marchy asked about the break and enter totals on the business side, if there was a certain area of town being impacted and the Chief advised that it can be broken down by zone, but the number would be for the entire service area.

Sonny asked about violent crime and the decrease and asked if there was a number we should be shooting for to see a reduction and the Chief advised that zero would be the goal.

Ian asked if we have any idea if the 33% is from citizen outside of Sault Ste. Marie. The Chief advised that without a deeper dive we couldn't say, but the people conducting break and enters are breaking in to find property to buy drugs. That is the number one reason across the municipality as to why people commit this crime, and it is a cycle of the drug subculture. The Chief noted that this is where we need treatment facilities for these individuals.

g) Statistical Reports - January & February 2024

The Chief reviewed the year to date for February and noted that robberies were down, sex assaults were down and IPV incidents are consistent. The chief reviewed the report. Theft occurrences are up significantly.

Sonny confirmed that businesses are not necessarily relying on their own practices to prevent theft and are relying on police to manage these occurrences. Police are responding after the fact and the Chief noted this opens up the area of crime prevention and to use the service to give them ideas as to how to reduce thefts. Sonny asked if there is an outreach team for this and the chief advised they can all and we have a team that would provide advice. The overall call would be to reduce crime and calls for service.
